PROGRAMS & PRODUCTS

SFAC provides a variety of services to help released prisoners transition from life in prison to life on the outside. Residents are carefully chosen, with the assistance of prison staff and the prison chaplain, to ensure that program participates have a genuine interest in turning their lives around. SFAC provides the following services to residents:

- ✓ HOUSING. The atmosphere in the house (SFAC rents two duplexes in Monroe, GA) is positive and nurturing. Residents are required to pay rent.
- ✓ RE-ENTRY SERVICES. SFAC helps residents get a new ID card, sign up for

food stamps, buy clothes, and attend their parole interviews.

- ✓ JOB SOURCING. SFAC helps residents prepare a resume and establish connections with local businesses willing to hire persons with a past criminal record.
- FINANCIAL MANAGEMENT. Residents go through the Crown Financial's "God's Way of Handling Your Money" financial management program.
- ✓ SUBSTANCE ABUSE CLASSES. Residents with a history of substance abuse are taken to local church-run AA or NA meetings.
- ✓ FAITH FORMATION. Residents are required to attend church and weekly Bible studies, and are assigned a Christian mentor.

PROGRAM IMPACT

SFAC's goal is to lower the percentage of released prisoners that return to prison which is presently over 40% within three years of release. (State of Recidivism: The Revolving Doors of America's Prisons, The Pew Center, April 2011.)

In the last three years, SFAC has provided residential services to 100 released prisoners with the following results:

- ✓ 69% are known to be contributing members of society with jobs and money in a savings account
- ✓ The status of 20% previous residents is unknown. This is due to residents leaving the program on their own as a result of poor decisions.
- √ 3% are deceased.
- √ 3% are addicted to drugs
- ✓ 5% have returned to jail

- ✓ "Faith Based Contributor of the Year" awarded by Georgia Department of Corrections in 2014
- ✓ The Full Gospel Businessmen Fellowship in America named SFAC its 1st inductee into its Prison Ministry Hall Of Faith in 2015

MINISTRY UNIQUENESS

- ✓ As opposed to some transitional homes, SFAC offers Christian counseling and life-skills programs, not just a bed.
- ✓ SFAC's screening process enables it to accept candidates with less probability of returning to prison.
- ✓ Special attention is given to the residents' Christian walk; Bible studies and church attendance are required.

CURRENT FINANCIAL NEEDS

- ✓ \$12,000 provides housing for four residents for one year
- ✓ \$4,000 provides food and clothing expenses for one resident for one year
- **✓** \$5,000 provides all the transportation needs for the ministry for one year
